

1. Information on the collection of personal data

Herewith we inform on the collection of personal data while using our website. Personal data collected is all data that is personally applicable to the user, e.g. name, address, e-mail address, user behavior.

Should we use contracted service providers for individual functions of our online services or wish to use your data for advertising purposes, we will inform you in detail below on the respective transactions. In doing so, we also name the specified criteria for the data storage duration.

2. Collection and usage of personal data (processing, purposes and legal basis)

Art. 6 I lit. A DS-GMO serves our company as the legal basis for processing operations where we obtain consent for a particular processing purpose. If the processing of personal data is necessary to fulfill a contract of which the data is partly subject, as is the case, for example, in processing operations necessary for the supply of goods or the provision of any other service or consideration, processing shall be based on Art. 6 I lit. b DS-GMO. The same applies to processing operations that are necessary to carry out pre-contractual measures, for example in cases of inquiries regarding our products or services. If our company is subject to a legal obligation which requires the processing of personal data, such as the fulfillment of tax obligations, the processing is based on Art. 6 I lit. c DS-GMO. In rare cases, the processing of personal data may be required to protect the vital interests of the data subject or another natural person. This would be the case, for example, if a visitor to our premises were injured and his or her name, age, health insurance or other vital information is required by a doctor, hospital or other third party entity. In such cases the processing of personal data would be based on Art. 6 I lit. d DS-GMO. On this legal basis, processing operations that are not covered by any of the above legal bases are required if processing is necessary to safeguard the legitimate interests of our company or a third party, unless the interests, fundamental rights and fundamental freedoms of the person concerned prevail. Such processing operations are particularly granted to us as they have been specifically mentioned by the European legislator. In this regard, it is considered that a legitimate interest could be assumed if the data subject is a customer of the controller (recital 47, second sentence, DS-BER).

Automatic decision making and profiling

We will inform you as part of the aforementioned Privacy Policy when we conduct automatic decision-making and profiling procedures, sharing detailed information about the logic involved, and the scope and intended impact of such data processing.

Obligation to provide personal data

We are not obliged to provide personal data.

2.1. Survey of website for informational purposes

When our website is visited for informational (no registration or otherwise provision of personal information), we will only collect the personal data that the browser transmits to our server. If a user wishes to visit our website, we collect the following information that is technically necessary for us to display our website and to ensure its stability and safety. The storage period is 30 days.

The legal basis for their collection is Article 6 (1) sentence 1 lit. f DS-GMO.

The following data is collected:

- *IP address*
- *Date and time of the request*
- *Time zone difference to Greenwich Mean Time (GMT)*
- *Content of the request (concrete page)*
- *Access status / HTTP status code*
- *Transferred amount of data*
- *Website from which the request came*
- *Browser*
- *Operating system and its interface*
- *Language and version of the browser software*
- *Internet service provider of the accessing system*
- *Device type*

3. Additional website features

In addition to the purely informative use of our website, we offer various services that can be used. To access these features, you will generally need to provide further personal information that we use to offer the services and for which the aforementioned data processing principles apply. In part, we use your data to process information from external service providers. These have been carefully selected and commissioned by us, are bound by our instructions and are regularly inspected.

Personal data collected will not be provided to third party entities, insofar as there are no grounds for permission in accordance with Art. 6 DS-GVO. For example, we may disclose your personal information to third parties when contracts or similar services are offered by us in partnership with third parties. For more information, the user may reference their personal data or in the description of our services below.

Transmission to third party countries:

Insofar as our service providers or partners are based in a state outside the European Economic Area (EEA), we will inform you about the consequences of this circumstance in the description of our services.

Storage time:

Regarding the storage duration of your collected data, you will be given more information regarding the individual services. Insofar as continued storage is required for legal reasons, we will restrict your data until the expiration of these retention periods for further use and delete them when the deadlines expire.

3.1 Other uses of our website

cookies

"Cookies" are small files that are stored on users' computers. Different information can be stored within a cookie. A cookie is primarily used to store the information about a user (or the device on which the cookie is stored) during or after online activity. Temporary cookies, or "session cookies" or "transient cookies", are cookies that are deleted after a user leaves an online service and closes their browser. In such cases, a cookie, e.g. the contents of a shopping cart are stored in an online store or a login portal. The term "permanent" or "persistent" refers to cookies that remain stored even after the browser has been closed. Thus, the login status will be saved if a user visits the site after several days. Likewise, in the aforementioned cookie example, the interests of the users can be stored, which are then used for range measurement or marketing purposes. A "third-party cookie" refers to cookies that are offered by providers other than the person who manages the online site (otherwise, if it is only their cookies, this is referred to as a "first-party cookie").

We can use temporary and permanent cookies to clarify this in the context of our privacy policy.

If users do not want cookies stored on their computer, they will be asked to disable the option in their browser's system settings. Saved cookies can be deleted in the system settings of the browser. The exclusion of cookies can lead to functional restrictions of online services.

A general contradiction to the use of cookies used for online marketing purposes can be found in a variety of services, especially in the case of tracking, this is explained via the US website <http://www.aboutads.info/choices/> or the EU website <http://www.youronlinechoices.com/>. Furthermore, the storage of cookies can be achieved by switching them off in the settings of the browser. Please note that not all features of this online website may be used. With the application of the DSGVO 2018, webmasters are obliged to follow the basic regulation published under <https://eu-datenschutz.org/> and to inform their users accordingly about the collection and evaluation of data. The lawfulness of the processing is justified in Chapter 2, Article 6 of the GDPR. In accordance therewith, cookies have a validity period of 30 days.

If the user would like to avoid such a collection of profile information, they should log out of the respective social media platform.
